Video visitation is an easier way to spend time with a loved one in custody at one of our jails. You can avoid long lines, scheduling conflicts and provide a better environment for children to interact with a family member. The service can be accessed at either our **Video Visitation Center** or anywhere with internet access from your smartphone, tablet or computer with a webcam.

Video Visitation will not be permitted while operating any motor vehicles or any machinery, or while performing any unsafe activities.

The Broward Sheriff's Office **Video Visitation Center** is located on *Oakland Park Blvd.* in between *NW 31st Ave.* and *State Road 7* in the Lauderdale Market Place Plaza.



### Video Visitation Center schedule start times are:

- 7:45 am to 1:45 pm and 3:45 pm to 9:45 pm - seven days a week for Paul Rein Detention Facility, North Broward Bureau, Main Jail and the Joseph V. Conte Facility.
- North Broward Unit 11A, 11B, 11C, and 11D starts at 7:45 am to 1:45 pm and 5:00 pm to 9:45 pm - six days a week.
- All visits must be scheduled and approved prior to arrival.

## You now have several options to visit your incarcerated loved one.

1. You can visit our brand new state of the art **Video Visitation Center**. The center provides two one hour visits per week, free of charge upon availability.



2. Video visitation will allow you to visit your incarcerated loved one from anywhere as long as you have WIFI or internet access using your Android™ or Apple® device or personal computer with a webcam. Visitors are required to create a **Securus Online** account by going to [videovisitanywhere.com](http://videovisitanywhere.com).



Visitor accounts may take up to 48 hours for approval. All inmates will receive two one hour visits per week via the **Video Visitation Center**. Available video visitation times will be shown at the time of scheduling. Video visitation is available seven days a week from 7:45 am to 9:45 pm, although some restrictions may apply. Visitation is subject to postponement or cancellation due to jail emergency and administrative reasons. Cancellation notifications will be sent via email or phone.

### How do you benefit from this change?

- **Stay Connected** - Give your loved one the chance to feel closer to you and your family by seeing you at home and sharing in special moments.
- **Control Your Schedule** - You can now participate in Video visitation sessions seven days a week. Choose your own day and time.
- **Visit More Often** - The Video Visitation Center provides two one hour visits per week, free of charge upon availability and up to four sessions from home. A Video visitation session from home is just \$5 for 30 minutes.

A one-time registration is required prior to receiving access to remote and scheduled visits at our **Video Visitation Center**. Appointments are available by scheduling only, and may be scheduled, modified or cancelled not less than one day to no more than seven days in advance.



- Effective immediately, all visits for the following facilities will be conducted at the **Video Visitation Center**:
  - ▶ Main Jail
  - ▶ Paul Rein Detention Facility
  - ▶ North Broward Bureau
  - ▶ Joseph V. Conte Facility
- At this time, attorneys will continue to visit their clients at the facility where the inmate is located.
